Highlights

Nowadays, protection to building is not the only purpose in the development of coating system. It is also important to create different kinds of texture or finishing by the coating materials. Raw finishing like fair-faced finishing and wood finishing are popular recently. How to achieve the good performance and nice appearance of coating system would be the key issues for paint manufacturers to investigate.

In this workshop, new decorative coating system would be introduced and demonstrated. Fair-faced finishing is one of the topics and different application tools for achieving different styles of fair-faced finishing would be shown. Even though stone textured coating system has existed in market for many years, new tools for easier application and new finishing would be introduced in the workshop. Apart from materials in wet form, the prefabricated stone or wood textured coating sheet would also be introduced to demonstrate how we could achieve nice finishing in eco-friendly and easier way. Attendees can also try to do the application by themselves to experience what the new coating system is.
